The County Borough of Conwy (Dolwen Road Old Colwyn)
(Temporary Prohibition of Traffic) Order 2020

NOTICE IS GIVEN that the Conwy County Borough Council has made an Order, the effect of which will be to prohibit any person to proceed in that length of Dolwen Road Old Colwyn from Bryn Rodyn to Bro Elian.

The Order is necessary to facilitate works by Welsh Water. The alternative route will be continue along Abergel Road (A547) to its junction with Grosvenor Road then turn left and continue to the junction with Lansdowne Road then turn right to proceed on the B5113, turn right to follow the B5381 and continue to the diversions end approaching the junction of Dolwen Road. Vice versa for vehicles travelling in the opposite direction and will be signed accordingly.

The Order comes into effect on 27 July 2020. It is anticipated that the road will be closed for a maximum period of 3 weeks.
