14. CONWY COUNTY COUNCIL AND CLLR. IFOR LLOYD MATTERS

Cllr. Lloyd reported that £500,000 had been made available to repair the rural roads. It was not known how this would be spent at the moment.

Cllr. Lloyd had been asked to attend a Committee meeting on Rural Farms and that he had been asked to complete a questionnaire the answers given were:-

Q1 - That young families should be encouraged to stay in the rural areas particularly farmers and to also encourage the Welsh language to thrive.

Q2 - Employment on the land is low and it is difficult to employ people to work it.

Q3 - The price of Milk, Lamb and Beef was causing concern and even more concerning was the escalating cost of feed. It was becoming uneconomical to farm.

Q4 - There was a decrease in stock volume but the Government continued to import Beef from South America.

Q5 - Welsh speaking schools should be encouraged because inward migration was making learning the Welsh language difficult.
