NEW APPLICATION

Reference: 0/52202 Applicant: Mr Mark Blissitt

Proposal: Farm tracks, for agricultural sheds to pig arks, to hay feeder (Agricultural Prior Approval)

Location: Aelwyd Uchaf, Peacful Mountain Farm, Betws yn Rhos, Conwy, LL22 8AG

The papers were viewed. A previous application to build a dwelling on this site was refused. Concerns had been expressed to Councillors. There were concerns that to grant such an application would set a dangerous precedent.

The proposed development would in essence be on a greenfield site and would be highly visible on the landscape. There are concerns that it will impact on the heritage byway in that area and that there would be a likelihood of increased traffic on the access road. A question was posed as to the long-term sustainability of the enterprise. There are concerns that this development may be contrary to Technical Advice Note 24. The Council agreed that they were therefore unable to support the planning application.

The Council will discuss the application at future meetings where any additional documents posted onto the portal will be considered.

It was noted that the name 'Peaceful Farm' is recorded on the planning application. There is apparently no such farm. Is this a change of name for Aelwyd Uchaf. Is there any process that needs following to change a name of premises

The Clerk to write to the Planning Department with the decision and to query the name change.

Proposal: Outline consent for the erection of a new rural enterprise dwelling on land at Bryn Ffanigl Ganol, Abergele

One question that was raised is whether this proposed development would attract a Section 106 contribution- ideally towards affordable housing. The Clerk to pass the comments onto the Planning Department.

There is a concern that the application will potentially lead to a wind farm being developed in that area in the future. This will be a matter that will have to be considered if that time comes.

Other that the future issues there is no formal objection by the Community Council to the application and are content for the final decision to be made by the Planning Department.

11. INTERNAL AND EXTERNAL AUDIT MATTERS.

The final report from the Wales Audit Office is still awaited. This is similar to many Community Councils.

12. CONWY COUNTY COUNCIL MATTERS - COUNCILLOR IFOR LLOYD

Councillor Ifor Lloyd updated that on the 12th December 2024 details were received from the Welsh Assembly of the Provisional Local Government Revenue and Capital Settlement for 2025-26 for county and county borough councils

Conwy will receive £218,586,000 for 2025/26 which represnt5s an increase of £7,835,000 (3.7%)

Councillor Lloyd will forward the briefing papers for sharing with the Councillors.

13. MAINTENANCE OF RESOURCES WITHIN THE COMMUNITY COUNCIL AREA.

a. Playground at Betws yn Rhos/Llanelian

Contact has been established with David Dudley the Playground Inspector for Conwy County Council. The proposals for the Playground and the estimates have been shared with him. He agrees with the G.L. Jones assessment that the current equipment will need refurbishing, However CCBC do not have the funding to carry this work out.

In relation to the estimate from Creative Play Mr Dudley stated that the equipment is suitable for Schools but not for public playgrounds. He stated that he will make contact in January 2025 and assist with suitable Companies and will also assist regarding Grant applications.

There will be a requirement for grants to be applied for and the Clerk will liaise with CVSC in due course.

b. Defibrillators

With regard to the siting of a defibrillator in the Dawn area the Clerk had shared the E mail from Mr Ifan Rowlands of Conwy Council that the location was assessed buy Scottish Power and was not suitable for the siting of a power source. The Clerk agreed to explore if there is a possibility of having a Solar Power source for a defibrillator in that area.

The Clerk reported that 5 new pads had been received and that the pads at the two defibrillators in Betws yn Rhos and the one in Llanelian had been replaced and will now expire on 15/6/2006.

The defibrillators at Dolwen and Holland Arms expire on the 21/3/2025 and will be replaced at that time. Still waiting for the defibrillators at Llanelian and Holland Arms to be transferred to the Community Council account.

c. The Hub'/ 'Yr Hwb'.

Volunteers are still required to supervise the meetings which will run between 9:00 and 12:00pm every Tuesday morning at the Sports Pavilion, Betws yn Rhos.

d. Flower beds/Public Benches, Abergele Road.

Hilda Gibbs to carry out the maintenance moving forwards.

e. Toilet Facility at Betws yn Rhos/Llanelian.

Councillor John Evans updated that the Church committee at Betws yn Rhos were looking at refurbishing an out building as a public toilet which would negate the need to build a new facility. Further updates will be given when there is progress to report. The Community Council agreed to provide necessary assistance.

The Clerk reported that Gary Williams of Conwy County Council was aware that the Community Council wanted to operate the Toilet facility at Llanelian. Mr Williams had supplied the costings for the running of the toilets for 2024/25 and had assessed that it would cost approximately £6,826.87 for the forthcoming year. It was agreed that there would be a need to include this costing in the Precept Application. The toilet block is now closed until April 2025.

f. General issues

The Clerk had written to ERF at Conwy Council regarding the barrier at the end of the public footpath and also the decking on the river bank at Llais Afon flats. They had acknowledged receipt under reference 112632. The work is classed as non-urgent

The issue raised on the 15th July by Councillor Irwedd Griffiths regarding the roadway near Nant Cochl has yet to be attended to.

In respect of the issue of no covered Bus Stop in Betws yn Rhos village. The Clerk has raised the issue with ERF and a reply is awaited.

Following concerns raised by local residents that a large mobile home had been transported to Glan Gors, Llanelian. The Planning Department had responded that it was additional living accomodation and there were no planning issues. Regarding the report that was received regarding a tree growing at the wall near the old toilets/flats at Llais Afon Inn. The Clerk had reported the matter to ERF. It was not on Council land and there were no details on the Land Registry as to who owned the land. The County Council were making further enquiries.

Regarding the issue with a tree overgrowing onto the roadway at 2/3, Dolwen Road, Betws yn Rhos. The Clerk to enquire again with ERF

No update as to the requirement to move the Monkey Tree as the planning decision was still awaited.

The Christmas lights at Betws yn Rhos had beeen welcomed by the Community. The Clerk will arrange for Conwy Council to remove the lights. Councillor Bryn Jones agreed to store them again.

Reports had been received regarding the state of the B5383 Dolwen Road from Dolgau to Dolwen that needs a road sweeper attending, The Clerk will write to ERF with the request.

14. ANNUAL BUDGET / PRECEPT

A discussion took place regarding the forthcoming Precept application. The application for the 2025/26 precept has to be submitted by the 17/1/2025.

The following will need to be included in the Precept application submitted.

- Costings for the Community Council taking over the Llanelian Toilets. An estimate of £4,800 was agreed
- 2. BT Wi Fi cost for Betws yn Rhos and Llanelian circa £936 per annum
- 3. Defibrillator pads costs £240.00
- 4. Clerk's salary SCP 17 to be increased on1/4/25 to £15.58 per hour.
- 5. Application received from Mrs Ann Vaughan requesting financial assistance of £600.00 for the grass cutting at Trofarth Cemetery for 2025. £500.00 was agreed

- 6. Application received from Richard Hughes, Hyfrydle Chapel, Betws yn Rhos requesting financial assistance towards
- Eisteddfod Calan Mai which is being held on the 26/4/2025.
 £300.00 was agreed

The Annual budget for 2025/2026 - £20,387.76 -was discussed and it was agreed by all

It was agreed that the precept application should be £18,000 with the Community Council utilising £2,387.76 from balances.

Councillor Gwyn Jones updated that Betws Sports Association had communicated with him requesting a grant from the Solar Park for the extended car park. The estimate was for over £69,000. There would be a need to obtain further estimates prior to any grant application being submitted to Solar Park

There being no further business the meeting closed at 10.pm
